## Wattana Wittaya Academy Announcement

W.W.A. 15/2022

**Subject : Measurements to prevent and monitor problems from using Marijuana or Hemp in Wattana Wittaya Academy students.**

According to the Bangkok Metropolitan Administration announcement declaring a marijuana and hemp-free zone in schools affiliated with Bangkok Metropolis by the virtue of Section 49 of the Act Bangkok Metropolitan Administration Regulation B.E. 2528 (1985), stated about surveillance of problems arising from the use of Marijuana or Hemp amongst students in Schools affiliated with Bangkok Metropolis – dated 15 June 2022. Wattana Wittaya Academy, therefore, is announcing measurements align with that as following;

1. Wattana Wittaya Academy must be marijuana- and hemp-free zone.
2. No selling of food, snacks or beverages with marijuana or hemp as ingredients in Wattana Wittaya Academy.
3. No advertising of food, snacks or beverages with marijuana or hemp as ingredients in Wattana Wittaya Academy.
4. School executives, teachers and staffs in Wattana Wittaya Academy set a good example for students and monitor students to prevent the use of marijuana or hemp.
5. Wattana Wittaya Academy provides knowledge and understanding of marijuana and hemp and the danger these pose through classroom learning and activity for students at all levels.
6. Wattana Wittaya Academy organize medium and academic activities to emphasize the risks of consuming marijuana or hemp.
7. Wattana Wittaya Academy runs public relations campaigns to increase student awareness of the impact of marijuana and hemp on physical and mental health.
8. Wattana Wittaya Academy coordinates with parents, surrounding communities and merchants in school areas to prevent the sale of food, snacks or beverages with marijuana or hemp as ingredients.
9. Wattana Wittaya Academy coordinates with public health offices 21, Thadthong Temple and district offices in monitoring and preventing the use of marijuana and hemp among students.
