### Subject: Subsidy for Learning Appliance of the Second Semester of 2024 Academic Year

Wattana Wittaya Academy has received the subsidy for learning appliances of the Second semester of 2024 academic year from the government on behalf of all eligible students. Hence, the school would like to announce the procedure to pick the subsidy up as per below:

#### 1. The amount of the subsidy in each level

Level	Learning Appliance
Kindergarten 1 - 3	145
Primary 1 - 6 Except English Program	220
Secondary 1 - 3	260
High school 4 - 6	260

#### 2. Picking up the subsidy

2.1 The subsidy could be picked up from 15 January to 28 February 2025, 08.00 am – 16.00 pm at the Accountant Office, Administrative building. (except public holidays)

##### 2.2 Requested documents

2.2.1 Receipt of purchase for the learning appliances. (full tax form)

2.2.2 In case the parents or guardians represent the students, a copy of id card together with student id card, or student's card, or house registration is required with certify true copy signed.

#### 3. The receipt of the purchase has to be in full form, depicting;

3.1 Name of the shop, address and telephone number.

3.2 Date/Month/Year of purchase (from 1 November 2024 to 28 February 2025).

3.3 Name of the purchaser: student name and family name, one receipt per student.

3.4 List of the purchased learning appliances in details

The receipt for learning appliances has to identify every purchased item i.e. 2 pencils, 2 erasers, and not using the word “leaning appliance” in general.

3.5 The seller has to sign clearly on the receipt.

**4. In case the parents/guardians or the students do not submit the requested documents within the period,** after 28 February 2025, the school received the right to ask the parents/ guardians or the students to give up her right for this subsidy for the second semester of 2024 academic year.

The school seeks cooperation from the eligible parents/ guardians and students in following the procedures strictly in order to receive the subsidy for learning appliances of the second semester of 2024 academic year since the school has to return the outstanding to the Office of the Private Education Commission.

Announcement is done on 10 January 2025.
